


CNB ENDS INTERVENTION REGIME - 6.4.


The CNB 1 has ended the regime of foreign currency interventions to keep the CZK 2 low against the \mathfrak{E}^3 .

The CNB announced the move after an extraordinary meeting of the bank board. That means the bank will no longer prevent the Czech crown to dropping below the level of CZK27/€.

The bank repeated its previous announcement that it is ready to intervene either way if the crown starts becoming volatile. The CNB launched currency interventions in November 2013 to head off the danger of deflation and weakened economic growth.










MF⁷ PREDICTING 2.5% GDP⁸ GROWTH - 6. 4.

The MF downgraded its GDP growth estimate for this year to 2.5% from January's 2.6%, while it improved its forecast for next year to 2.5% from the previous 2.4%. The economy expanded by 2.4% last year. Economic growth will be driven by domestic demand led by household consumption expenditure and growing investment activities of companies and government institutions. A marked acceleration of annual growth in consumer prices above the inflation target of the CNB at the turn of 2016 and 2017 leads to a higher average inflation estimate of 2.4% in 2017, the MF said. For 2018, the MF expects a 1.7% inflation rate.



The unemployment rate, which dropped notably at the end of last year, will gradually lower to 3.3% to 2018, according to the MF's estimate. At this level, unemployment has a very

GDP can be determined in three ways, all of which should, in principle, give the same

result. They are the **production approach**, the **income approach**, or the **expenditure approach**. The **production approach** sums the outputs of every class of enterprise to arrive at the total. The expenditure approach assumes the value of the total product must be equal to people's total expenditures in buying things. The **income approach** determines GDP by finding the sum of all producers' incomes.

limited space for a further decrease, it said. The current account of the balance of payments is expected to stay in a slight surplus. The macroeconomic development may be affected adversely mainly by external risks, mainly the consequences of Brexit ¹⁰ and a further slowdown of the Chinese economy. The global economic growth may be affected by a possible change in the US economic policy. Uncertainty may also increase in connection with the approaching elections in France and Germany.

"There are also potential risks in the financial sector in some EU countries" connected not only with a high portion of unpaid loans in the balance of some large European banks but also with the future development of their profitability and capital adequacy," the MF said. The latest forecast of the CNB downgraded its GDP forecast for both this and next year to 2.8.



In February 2017, SA construction output decreased by 5.6% y-o-y, in real terms; non SA construction output fell by 7.0%. The planning and building control authorities granted by 3.8% more building permits, y-o-y, and the approximate value of permitted constructions increased by 13.6%, y-o-y. The number of started dwellings grew by 23.7%, y-o-y, and the number of completed dwellings increased by 11.3%, y-o-y.


In February 2017, SA ¹² industrial production increased at constant prices by 6.6%, y-o-y¹³. Non SA industrial production was higher by 2.7%, y-o-y.

SA industrial production increased by 0.7%, m-o-m¹⁴. The value of new orders increased by 7.3%, y-o-y.


Map 1: Regions, fuel prices, Petrol, 7. 4. 2017 (in CZK/I)


Unemployment²⁰ in the CR²¹ dropped to 4.8% in March down from 5.1% a month earlier. Some 356,112 people were without jobs last month – the lowest figure for March since 2008. Available jobs counted almost 151,000. The LO²² expect the unemployment rate to continue falling in the months ahead.







Consumer prices in March remained unchanged compared with February 0%, m-o-m. This development was primarily due to a rise in prices in 'alcoholic beverages and tobacco', which was offset by a decrease in prices in 'recreation and culture'. The y-o-y growth of consumer prices amounted to 2.6%, i.e. 0.1 p. p. ²³ up on February.



The CNB could start increasing interest rates at the end of 2017, governor Rusnok said. He said this would be

conditioned by a sustainable inflation figure at around 2%. The basic repo rate²⁴ has been at 0.05% since 2012.

CZK POSTING MODERATE GAINS - 10.4.

The CZK firmed moderately in, while strengthening all the way to CZK26.50/€ after the announcement of inflation data. The unit appreciated by 2h from March 7's afternoon values. It has gained nearly 50h since March 6, when the CNB announced the end to its forex intervention regime.

MF TO REDEEM BONDS FOR RECORD CZK90BN - 11. 4.

The MF paid nearly CZK90bn for government bonds sold on the financial markets before the breakout of the financial crisis in April 2007 and says this is a record one-off payment for bonds.

The MF also expects to redeem bonds and treasury bills for around CZK261bn this year. Annual interest on the government bonds was 4%, costing the MF annually CZK3.9bn.

The MF has no problem with redeeming these bonds because in the Q1²⁵ 2017, it borrowed some CZK110bn with the average annual interest at 0.17% on the financial markets.

The MF took advantage of demand for Czech bonds caused by the expected exit from the forex intervention regime aimed at keeping the crown near CZK27/€.

Payment will be a big relief for the state budget, MF Minister Babiš said, because the interest rate cost being excessive.

The MF has saved CZK2.2bn thanks to negative bond yields, Babiš said.

The MF will have to make another big payment of CZK70bn this year in November. This is a bond with zero interest held mostly by foreign investors. Other CZK6obn worth bonds will mature in January 2018. The MF was selling short-time bonds even with a negative yield from the end of 2015. Investors were thus paying to the state for lending it money.

This is why more than 2/5 of Czech state bonds in CZK are in the hands of foreign investors. In absolute figure, they hold bonds for CZK6o2bn out of the total amount of CZK1,433bn in bonds issued on the domestic market.

In January 2016, the share of foreign owners of Czech state bonds was less than 25%.

The MF should pay CZK254bn for state bonds in 2018 and thus far CZK236bn in 2019.

HEALTH & SOCIAL

BUS DRIVERS' STRIKE - 6.4.

≣

A strike by bus drivers began at midnight on March 5 with 5 regions, mostly in the north and east of the CR mainly affected. The biggest impact appears to have been in South Moravia where it was reported that 67 routes were cancelled and buses on another 61 routes reduced. The regional government subsidies 225 routes in total. The strike was reported to be much more patchy in the Olomouc, Liberec, and Ústí regions.

The government on March 5 night offered regions CZK420mn²⁶ to boost pay for drivers but this is less than half what might be required. The strike was sparked when some regional operators failed to honour a government promise for minimum wages to be boosted to CZK98.10/h for drivers behind the wheel.

CHANGES TO RESIDENCY PERMIT PROCEDURES - 7. 4.

The ChD²⁷ passed an amendment aimed at tightening up on the conditions for foreigners to get residency permits in the CR. The amendment, however, does not fulfil the worst fears of non-profit and human rights organisations with the right of a court appeal after a refusal maintained.

The government's own human rights council and minister had highlighted the danger of this change and labelled it as unconstitutional. The new rules allow proceedings to be stopped if the claimant has been proved to have lied or submitted false documents. Past criminal convictions can also be taken into account. The amendment will now go to the Senate.28

PAYMENTS FOR GOVERNMENT INSUREES - 11. 4.


Czech government approved on April 10, 2017, the proposed directive determining the assessment base for persons for whom the public health insurance payments are reimbursed by the government. The norm raises the total payments for state insurees by almost CZK3.5bn. The payment per capita will be raised by CZK49 to CZK969 per month.

(a) OECD TAX RATES ON LABOUR INCOME IN OECD²⁹ – 12.4.

The average tax wedge in the CR reached 43% in 2016 and rose thus from 42.8% in 2015.

According to a report published by the OECD, the CR showed the 8th highest tax rates on labour income within 35 member states. Slovakia ranked 12th with a value of 41.5%.

The average indicator for the entire OECD decreased to 36% in 2016.





Graph 13: OECD, Taxing wages, One-earner married couple at 100% of average earnings, 2 children, 2016 (in % of labour income)





HOURLY LABOUR COSTS RANGED IN EU28 – 11. 4.

Hourly labour costs ranged between ϵ 4.4 and ϵ 42.0 in the EU Member States in 2016. In 2016, average hourly labour costs in the whole economy (excluding agriculture and public administration) were estimated to be ϵ 25.4 in the EU³⁰ and ϵ 29.8 in the EA³¹.

However, this average masks significant gaps between EU Member States, with the lowest hourly labour costs recorded

in Bulgaria (ϵ 4.4), Romania (ϵ 5.5), Lithuania (ϵ 7.3), Latvia (ϵ 7.5), Hungary (ϵ 8.3) and Poland (ϵ 8.6), and the highest in Denmark (ϵ 42.0), Belgium (ϵ 39.2), Sweden (ϵ 38.0), Luxembourg (ϵ 36.6) and France (ϵ 35.6).

BILL TO RAISE SUPPORT FOR FAMILIES - 12. 4.

The ChD passed a government amendment to the law on state social support that will raise welfare payments to families with children. The Senate must yet to approve the bill and President Zeman sign it into law.

Under the amendment, parents of twins, triplets (as well as in other multiple birth cases) will receive a higher parental benefit. It will rise from the current CZK220,000 to CZK330,000 in total.

This measure will cost additional CZK400mn from the state budget in the first year, and CZK210mn a year in the following years because of a lower number of recipients. Tax relief for the first child will increase by CZK150 monthly as well.

The state budget will lose CZK2.1bn a year due to this change. The legislation will also extend the types of families that will be entitled to child benefits. Even the families with an income not exceeding the subsistence level 2.7 times will be entitled to them. Consequently, about 300,000 children would newly receive state benefits, which would cost CZK5bn extra from the state budget or CZK8bn in total.

At present about 400,000 children in the CR with a population of 10.5mn are entitled to child benefits.

A monthly child benefit will rise in the families where at least one parent works or has an income of at least the subsistence level by CZK300 to CZK800, 910 and 1000, according to the child's age. The amendment also introduces the possibility to draw parental benefits more quickly

MPs³² approved setting a cap of 65 years on the retirement age as of 2030. It will apply to those born after 1965. Pensions should also grow at a faster rate than ever before. "The purpose of this Act is to eliminate the previously unlimited increase in the retirement age," MLSA³³ Minister Marksová said. The law still has to be confirmed by the Senate and President Zeman.

Calculating higher pensions should be based on inflation and half of the average wage growth. Now pensions are increased by inflation and a third of the average wage growth. "That is an increase by CZK22.3bn," said MF Minister Babiš. Monthly pension would increase by an estimated average of

Monthly pension would increase by an estimated average of roughly CZK500 next year, if the new indexation formula comes into force.

TIGHTENING RULES ON EMPLOYMENT AGENCIES - 12. 4.

The amendment to the Employment Act approved by the ChD will allow the prosecution of disguised employment mediation. The Senate must yet to approve the amendment. According to the amendment, a fine of up to CZK5mn will be possible for "disguised employment mediation", i.e.

mediating the workforce without respecting legal conditions. The change should particularly restrict unrespecting the principle of comparable wages and working conditions of temporarily assigned employees and, i.e. in final consequence, circumventing social security and health insurance and advances on income tax.

In addition to CZK500,000 bail, which an employment agency will have to deposit, the amendment will also increase penalties for misconduct.

Agency employment has been criticized for the poor working conditions and low wages of mediated workers in the past. The number of workers that companies have mediated from employment agencies has increased by 62% over the past 5 years. While agencies sent 171,800 people to companies in 2011, it was 277,400 people last year.

Agencies often send foreigners to do work in which Czech citizens are not interested anymore. According to the APACR³⁴, in addition to a 250,000 legally employed agency workers, there is at least the same number of illegal workers.

ICT & SERVICES & TRANSPORT

CYBER OFFICE TO HAVE OWN BUDGET CHAPTER - 10. 4.

The NUKIB³⁵, to be set up this year, will have own chapter in the state budget, according to an amendment to the law on the state budget for 2017 approved by the government today, PM³⁶ Sobotka said.

The cyber office is to be formed on July 1 by separation from the NBU³⁷ which supervises cyber security in the CR now.

"The government's goal is that this office emerges already now. This is why we are submitting the change in this year's state budget," Sobotka said. The spending of the new office will reach around CZK214mn this year, CZK139mn of it will be capital expenditures and CZK75mn current expenditures.

The approved amendment plans that the new office will gain CZK183mn directly from the NBU budget and CZK31mn from unused spending.

In this year's approved budget, NBU has around CZK490mn. From NBU's current tasks, the new office will be solving cyber security, part of issues linked with the protection of secret information in information and communication systems, cryptographic protection and non-public services within satellite system Galileo³⁸.

The cyber office will be based in Brno. The government decided last year in November that a new building with the capacity for up to 400 employees will be constructed for the centre. The construction is to take place in 2018 to 2023.

DIGITAL AGENDA COORDINATOR TASKS – 11. 4.

According to the PM Sobotka, new government digital agenda coordinator Ondřej Malý should focus on reduction

Sobotka said he considers digital agenda very important given the industry digitisation strategy and new services in the digital area and that he hopes coordinator will manage to coordinate activities of the ministries dealing with digitisation.

FLYBE TO CONNECT PRAGUE WITH LONDON - 11. 4.

The SmartWings offers a new direct flight between Prague and the South-Spanish city of Almería from April 6, 2017. There will be 3 flights a week on this line.

As of May 8, 2017, British low-cost airline Flybe plans to run a connection between Prague and London-Southend. The carrier will offer 5 flights a week.

Russian carrier Ural Airlines plans to increase the number of flights between Prague and Yekaterinburg in the 2017 summer season. The current 2 flights on Thursday and Sunday will be completed by a new connection in Tuesday as of May 9. All flights will be operated on an Airbus A320 aircraft with a capacity of 160 seats.

AMENDMENT TO STRENGTHEN CYBER SECURITY – 12. 4.

The ChD passed an amendment to the cyber security law that would apply to operators of information systems in transport and energy industry as well. The Senate is yet to assess the bill. The legislation has transposed the respective EU directive in the government wording.

The CR is one of the first EU member states to transpose this EU directive³⁹, several months ahead of the deadline, said PM Sobotka who called cyber security one of the priorities of his cabinet this year.

Under the amendment, the newly included groups of entities will have to take steps to prevent possible security risks. They will be obliged to report possible cyber incidents to security offices. This duty will also apply to the providers of digital services, for instance, platforms for electronic trading and browsers. Sobotka said if the Senate passed the bill smoothly, the new office could be established in the summer, at the latest in the autumn.

The respective EU directive is to secure a common security level of networks and information systems in the EU that create one of the fundamental elements of the functioning of its internal market.

SUPPORT FOR TOURISM FROM CHINA - 12. 4.

The number of Chinese tourists coming to the CR rose by 56% in the Q1 2017, MRD⁴⁰ Minister Šlechtová said when opening a Czech-Chinese business forum in Zhengzhou.

Accompanied by a business delegation, Šlechtová primarily wants to enhance the two countries' relations in the sphere of tourism. Šlechtová started her visit to Henan on April 9.

On March 11, she moved to the town of Kunming in the Yunnan Province and discussed the opening of another direct flight route between the CR and China what should start in H1⁴¹ 2018.

Šlechtová wants to attract even more Chinese tourists to the CR and convince the Chinese authorities to prepare conditions for Czech tourists in China and encourage their interest.

ENERGY & INDUSTRY

EU DIRECTIVE ON OIL STOCKS − 6. 4.

The CR currently doesn't fulfil the Oil Stocks⁴² Directive, the ASMR⁴³ said. According to the directive, EU countries with no oil of their own must maintain emergency stocks of crude oil or petroleum products equal to at least 90 days of net imports. However, the CR's current oil reserves would only last for 87 days. The ASMR has already informed the government and the EC⁴⁴ about the situation.

■ WANO INSPECTION ENDS IN DUKOVANY – 7. 4.

An international inspection ended in Dukovany NPP 45 and WANO 46 has submitted proposals for improvement in 9 areas.

Part of WANO experts will arrive in 2 years to see how the power plant has coped with these recommendations.

The WANO experts also highlighted 2 good practices in Dukovany which can be used in other NPPs as well.

A major part of the recommendations concerns areas on whose improvement the NPP already works. It mentions in this connection, for example, supervision over the work of suppliers, prevention of human faults, inspection activities and a programme to prevent foreign objects from getting into open technology.

The number of the proposed improvements for Dukovany was a half lower than during WANO previous inspection in 2012.

This was the 4th WANO inspection in the Dukovany plant. Besides representatives from countries from WANO's Moscow centre, people from WANO centres in the USA, France and Pakistan arrived in Dukovany as well.

With installed capacity of 2,040 MW 47 , Dukovany covers roughly 1/5 of the CR's electricity consumption. The power

plant 4 four units and unit 1 has been offline since January 20. Last year, Dukovany supplied 11.954 TWh⁴⁸ of electricity to the grid.

ČEPS⁴⁹ INVESTED CZK INTO DEVELOPMENT OF GRID – 10. 4.

ČEPS has for 2016 posted profits before taxes totalling CZK2.07bn. It spent roughly CZK 4.7bn on the development of the grid. Its profits grew CZK 56mn y-o-y.

The main construction projects included the completion of new mains V458 Krasíkov - Horní Životice.

On September 30 ČEPS issued bonds with a nominal value of CZK500mn repayable in 5 years.

ŠKODA AUTO'S CAR SALES – 11. 4.

Škoda Auto registered the highest car sales in its 122-year history in the Q1 2017 and in March alone, it sold 283,000 cars to clients in the Q1, up 2.1% y-o-y.

Sales in March increased by 2.1% to 108,500 cars.

A significant increase in the sales of the Škoda's cars was seen in Western (+7.9% in March, +6.6 in Q1) and CE ⁵⁰ Europe (+14.5% in March, +14.9 in Q1), but recorded a drop on the Chinese market (\blacktriangle 14.8% in March, \blacktriangle 11.4% in Q1).

The development in China can to a significant extent be explained by raising of the tax burden on several segments of cars, which also concerns Skoda Auto. The company had expected such development and it believes that the demand will get back to normal in the Q2⁵¹ 2017.

LITHIUM AT CÍNOVEC - 11. 4.

Cínovecká Deponie will invest CZK hundreds of millions in the start of lithium mining at Cínovec. The extraction could start within several years. Currently, preparatory work is underway, followed by the construction of a raw-material processing, employee hiring, technology commissioning, and distribution of the mined-out raw material.

The estimated volume of pure lithium at the Cínovec surface deposit is roughly 2,300t⁵², which corresponds to 10,000–15,000t of lithium carbonate.

REGIONAL COMMISSION FOR NEW NUCLEAR SOURCE - 11. 4.

Representatives of the Vysočina region approved the establishment of a commission for the construction of a new nuclear source at the Dukovany NPP. Regional governor Běhounek was appointed the head of the commission.

The task of the commission will be to negotiate the process of preparations for the construction of a new unit at Dukovany in the years to come.

The commission should help reveal weak points and problems that might endanger the investment and create pressure on relevant authorities.

The commission consists of representatives of political groups, civic association Energetické Třebíčsko, a civic security commission, ČEZ 53, representatives of the South Moravia regions and other entities.

According to Běhounek, the commission is the only advisory body of the Vysočina region in which the neighbouring South Moravia region will have its representatives.

VW⁵⁴ RAISES SALES – 12. 4.

The VW sold a total of 8,123 cars on the Czech market in the Q1 2017. This represents a growth by 50% y-o-y. The company sold 2,842 cars (+41%) in March. In terms of the body, the best-selling models are hatchbacks (2,720 units; +43%), estate cars (1,813; +44%), SUV ⁵⁵ (1,178; +134%), and MPV ⁵⁶ (1,034; +85%). The best-selling models are: the Golf, the Passat, the Tiguan, the Touran, and the Polo.

Date of General Election - 7.4.

The elections to the ChD will take place on October 20-21, President Zeman said. The president chose the latest date possible according to the constitution, which says elections must be held at least 30 days before the end of a 4-year parliamentary term with the president obliged to give at least 90-day notice of when they will happen. The deadline for political parties to submit the list of their candidates is August 15. PM Sobotka said account that he was ready to sign the proposal.

FTA⁵⁷ AFTER BREXIT − 10. 4.

The government approved CR's position in the negotiations about Great Britain's exit from the EU. The priority for Brexit is unified action by EU27. PM Sobotka has stated that the key issue for the CR is free movement of people and Czech citizens' rights, mutual relationships, financial settlement and legal continuity. The CR aims to arrange complex FTA that will allow maintaining Czech export to the UK. PM Sobotka will present information regarding Brexit in the ChD on April 12, 2017.

SOUTH BOHEMIA GOVERNOR RESIGNS - 11. 4.

The South Bohemia Region's Governor Zimola (ČSSD⁵⁸), is leaving his post and he will officially resign at the closest meeting of the regional body, he said, adding that the ČSSD will attempt to form a new coalition.

The coalition would be comprised in addition to the ČSSD by the South Bohemians 2012 movement, the For South Bohemia coalition and the KDU-ČSL⁵⁹, Zimola said.

He said he would propose to it his deputy Ivana Straska for the ČSSD.

The former coalition, which was formed by the ČSSD, the ANO ⁶⁰ and South Bohemians 2012 after the 2016 regional election, fell apart on March 10.

C-LINE OUT OF OPERATION THROUGHOUT EASTER – 11. 4.

A stretch of the C-line of Prague's metro will be out of operation throughout the Easter holidays due to scheduled repair work on the tracks. Trains will not run between the stations Nádraží Holešovice and Pražského povstání from early Friday morning until late Monday night. A substitute bus service and special tram line will be in place.

PROTESTING HUMAN RIGHTS ABUSES IN CHINA – 12. 4.

The CR was one of 11 countries which signed a letter to the Chinese government highlighting human rights abuses. The letter was signed by on orders from the MFA⁶¹, according to Czech media reports citing confirmation from the MFA. The precise details of the letter has not been revealed, though it is said to highlight torture, prison isolation, and other abuses of lawyers and other involved in the promotion of human rights in China. The reports highlighted the fact that no publicity had been given in the CR to the move, said to have been initiated by the EU representation in Beijing. Four top Czech political figures, including the president and PM, signed a controversial declaration in October last year apologising for high profile meetings in Prague with the Tibetan spiritual leader the Dalai Lama.
