# Legal employment – basic rules

#### EU - citizen

Same rights as Czech Citizen

no work permit

no visa

#### **Non EU citizen**

Work and stay in the Czech Republic must be approved.

Special groups may have free access to the labour market (e.g. Students, family members)

Registration certificate (optional)





# **Emplying foreigner step by step**

#### **Pre-application**

Hiring process

Document collection, translation, verification (apostille, superlegalization, nostrification)

Publish open position at labour office (labour market test) or Work permit application)

Visa Programme application

Appointment at the embassy

### **Some benefits of Government Visa Programmes**

Support of approved employers

Dicreased administrative load of visa process (some documents may be replaced by employres declaration)

Guaranteed Appointment at the Embassy (Assigned by the Embassy)

Faster assessment times (Key and Scientific Personnel only)

Higher success rate (better communication – Employee – Employer – CI – MoI)
